



## FEES SCHEDULE 2018 - 2019

### APPLICATION FEE

A non-refundable Application Fee is payable at the time of application.

- VND 3,180,000 (per student)

### ACCEPTANCE FEE

A non-refundable Acceptance Fee is payable within 7 days from receiving an offer of a place to confirm your child's enrolment at the School.

- VND 31,800,000 \* for Kindergarten (Infant, Junior & Senior)
- VND 63,600,000 for Primary or Middle School (Years 1-11)
- VND 31,800,000 for Senior School (Years 12 & 13)

\* The Acceptance Fee for Kindergarten is half that for Primary. The remainder (VND 31,800,000) is payable when your child progresses to Year 1.

### ENGLISH AS AN ADDITIONAL LANGUAGE (EAL) FEE

This fee is payable if your child requires English language support as part of their curriculum. The level of English language support your child needs is determined at the time of interview/testing and is communicated to parents when the child is accepted into the School.

- VND 15,000,000 per semester for students in Years 1-6
- VND 19,000,000 per semester for students in Years 7-11

If the child no longer needs English language support during the Academic Year (as determined by the School), a refund can be offered on EAL fees from the date the child stops receiving English language support to the end of the semester.

### STUDENT SUPPORT SERVICES (SSS) FEE

Students requiring a modified or special education program will be required to pay an additional fee for special education needs. The SSS Fee is determined on a case-by-case basis according to the needs of the child and will be reviewed annually. The fee covers additional staffing and support for the child.

### DISCOUNTS

An Early Bird Discount of 1.5% off the Annual Tuition Fee is available if payment is made in full before 1 May 2018.

- Textbooks will be on loan from the School and collected at the end of the Academic Year.
- Accident Insurance only applies to accidents which occur at AIS or on an AIS activity.

## CONDITIONS

If a student is enrolled into the School after 1 October, the Tuition Fee (and any EAL Fee or Bus Fee) payable will be calculated on a pro-rata basis for the number of school days remaining in the academic year and based on the three instalments option. The balance of the current instalment period will be payable immediately, and the remaining instalments will be payable in accordance with the due dates noted in the table above.

The School reserves the right to increase the Tuition Fees during the academic year if the annualised inflation rate exceeds 10% during a Term, and/or if the VND depreciates against the USD by more than 5% from the first day of the academic year. In such cases, the School will publish the new fees on its website, and the remaining Tuition Fees payable on a three-instalment basis will be payable in the new published amounts.

## PAYMENT OF FEES

All relevant fees are payable before a student commences at (or returns to) the School. Parents are responsible for ensuring the payment of fees. This responsibility cannot be delegated to a company.

A 1.5% penalty per month is applied to all outstanding amounts owing 30 days from the due date as students stated in the Debit Note issued by the School.

The School reserves the right to withhold the school report and any academic transcripts of any student whose fees remain unpaid from such time. Any scholarships or discount on fees will be withdrawn and a new Debit Note will be issued. Students may be suspended or asked to leave the School for non-payment of fees.

Payment of fees are made by bank transfer or credit card. Cash payments can be made at the School Cashier for amounts under VND 30,000,000 only.

Fees must be paid in VND, or in USD where permitted under Vietnam's foreign currency regulations. Payments in USD will be calculated at the exchange rate for USD quoted by State Bank on the day of payment.

Instructions for payment of fees by bank transfer should reference the Student ID number contained on the Debit Note and the student's name. The Payer is liable for all bank charges. Documentary proof of payment by bank transfer must be provided to the School.

## REFUNDS

In the event that a parent/guardian wishes to withdraw a student, written notice must be provided on the standard Withdrawal Form, signed by the parents/guardians and returned to the School at least 8 school weeks before the Withdrawal Date (ie the last date on which the student actually attends school).

Failure to provide the required notice will result in forfeiture of the full amount of any Bond or Security Deposit held by the School. The School will refund a proportion of any prepaid Tuition Fee (and any EAL Fee) depending on the amount of notice given. The proportion to be refunded will be calculated on a pro-rata basis by dividing the number of school weeks remaining from the Withdrawal Date until the end of the current payment period by the total number of school weeks for that payment period.

If there is no prepaid Tuition Fee, or if the amount of any prepaid Tuition Fee is insufficient to cover any shortfall in notice provided, the parent/guardian will pay the School an amount equal to the Tuition Fee owing for that shortfall, immediately upon invoice.

Other monies owing to the School at the Withdrawal Date (eg fees, lost/damaged textbooks, unreturned library books, etc) will be also deducted from any refund (or, if no refund is owed, will also be payable by the parent/guardian, immediately upon invoice). The School reserves the right to withhold the school report and any academic transcripts of any student who owes money to the School at the Withdrawal Date. The Application Fee, Acceptance Fee, SSS Fee, and any other prepaid bus or extra-curricular fees are not refundable at any time.

The School will pay any Tuition Fee refunds to the person/company from whom it received the monies by telegraphic transfer in VND.

In the event that all or part of the School is closed temporarily or permanently due to pandemic, terrorism or for any other reason, the School will not be liable to refund any fees or other monies it has received.
